

Help Pets Live Longer, Healthier Lives!



August is Immunization Awareness Month. It is a good reminder that we should protect our pets, just as we protect our other family members, by getting recommended annual vaccines because:

1. Core vaccines prevent many pet illnesses, avoiding stress on your pet and costly medical treatments for preventable diseases.
2. Diseases seen in wildlife, such as rabies, distemper and leptospirosis, can infect unvaccinated pets and lead to serious illnesses.

3. Many areas, local or state, require certain vaccinations. For instance, Hamilton County law requires that all pets over 3 months of age have a current rabies vaccine.

Core Vaccines: Rabies, Distemper/Parvo for dogs and FVRCP for cats are the core recommended vaccines that pets should get annually.

A rabies vaccine can be given to pets 3 months of age or older. Pets receive a 1-year rabies vaccine first, and then can receive 3-year rabies vaccines thereafter.

Puppies/Kittens should receive a series of **three** Distemper/Parvo or FVRCP vaccines starting at 8 weeks of age to give them full protection. For adults that have not been previously vaccinated, Distemper/Parvo or FVRCP vaccines should be given once, with a booster vaccine in 3 to 4 weeks thereafter. After the first round of shots, pets should get these vaccines annually thereafter to keep them protected.

Non-Core Vaccines: Non-core vaccines are given depending on the pet's exposure risk and the requirements of groomers and dog parks. For dogs, these may include Bordetella (kennel cough), Canine Influenza and Leptospirosis. For cats, there is a feline leukemia vaccine which can be given after a cat tests negative for FIV/FelV. Cats that are indoor/outdoor cats should receive this vaccine to be protected from contracting FeLV from other outdoor cats.

We offer the rabies vaccine for \$10 and all other vaccines for \$15 each.

You can obtain these vaccines for your pet at a vaccine clinic appointment on Fridays between 8 a.m. and 2:30 p.m. - just call 513-721-7387 for an appointment.

For pet owners whose total household income is at or below 200% of the federal poverty guidelines, you may make a wellness appointment Monday - Thursday and for only \$40, your pet will get a thorough exam by our veterinarian, the core vaccines, a general dewormer, and discounted spay/neuter surgery if needed. - **Bequest in Will:** Make a gift to UCAN in your Will. You can leave a specific amount or the remainder (or a portion of the remainder) of your estate after other bequests are satisfied. Here is some suggested language: *"I give to UCAN Nonprofit Spay & Neuter Clinic, an Ohio nonprofit corporation, (the sum of \$___) (all or ___ percent of my residual estate) to be used for its general purposes."*
- **Charitable Trust:** If you have a charitable trust for tax purposes, you can name UCAN as a beneficiary under the trust.
- **Life Insurance:** Name UCAN as the beneficiary under a life insurance policy.
- **401(k) Retirement or Financial Account:** Name UCAN as the primary or contingent beneficiary under your retirement plan, your brokerage account



and/or money market, savings, checking or other accounts that allow transfer on death (TOD) or payment on death (POD) designations.
